The Fine Print

By signing and dating you are agreeing to the conditions as outlined below.

SKIPPER'S/OWNER'S RESPONSIBILITIES: The safety of a yacht and its crew is the sole and inescapable responsibility of the skipper/owner who must do his/her best to ensure that the yacht is fully sound, thoroughly seaworthy and manned by an experienced crew which is physically fit to face bad weather. The skipper/owner must be satisfied at the soundness of the hull, spars, rigging, sails and all other gear. The skipper/owner must ensure that all safety equipment is properly maintained and stowed and the crew know where it is and know how to use it. The skipper/owner is responsible for filing a current, valid rating certificate when confirming race entry and ensuring that the yacht is sailed in the race as specified in the rating certificate. Any change to rating subsequent to the filing of this entry form is to be reported to the Race Committee prior to 2100 Friday, 30 July, 2010.

INSURANCE: In consideration for participating in this event, I represent to the Cowichan Bay Sailing Association that my vessel has liability insurance currently in effect covering property damage, personal injury and death in an amount not less than CAD\$500,000 (USD\$400,000) per occurrence and that the policy covers yacht racing activities.

WAIVER: By proceeding with registration and participating in the regatta, I hereby acknowledge that I have read the rules and regulations issued for this event and agree to be bound by them. I also acknowledge that sailing is an activity with inherent risks of physical injury and / or fatality and, in consideration of my being permitted to take part in this event, I agree to release the Cowichan Bay Sailing Association (CBSA), its employees, directors, race organizers and volunteers, and any of their respective agents, officials, servants, and representatives (collectively and individually hereafter the "Releasees"), from and against all claims, actions, costs, expenses, and demands in respect to any claim for personal injury, death, or loss of or damage to any property, howsoever caused (collectively and individually hereafter "Claims") arising out of or in connection with my attendance at or taking part in the Cowichan Bay Regatta, notwithstanding that such Claim may have been contributed to or caused by the negligence of any of the Releasees. I further agree to waive and not to take any action with respect to any Claims and will indemnify the Releasees for any Claims brought by me or in my name or on behalf of my heirs, executors and / or assigns or any Claims brought by or in the name of any of my crew members, their heirs, executors and/or assigns.
